Notice of change of the underlying Index

The Unit Holders of UTP-A30+ FUND (UTP-A30+) are hereby notified that with effect from January 01, 2008, the underlying index for investments by UTP-A30+ shall be changed from "ABAMCO 30 Index" to "KSE-30 Index".

This notice is given by JS Investments Limited (Formerly JS ABAMCO Limited), the Management Company of UTP-A30+, pursuant to Clause 9.10 of the Trust Deed and Clause 4.2 of the Offering Document. The decision by JS Investments Limited to change the underlying index of UTP-A30+ from "ABAMCO 30 Index" to "KSE 30 Index" has already been approved by the Securities and Exchange Commission of Pakistan.

"KSE-30 Index" is calculated and reported by the Karachi Stock Exchange (Guarantee) Limited and is considered by JS Investments Limited to be a better, more representative and widely accepted free float-adjusted market capitalisation index.

Effective from January 01, 2008, UTP-A30+ shall start tracking the "KSE-30 Index" and all investments made by UTP-A30+ shall be in accordance with the Investment Policy as was applicable to the investments by UTP-A30+ in "ABAMCO 30 Index". The investments of UTP-A30+ in the "KSE-30 Index" shall be effected completely latest by March 31, 2008 to ensure that the change from "ABAMCO 30 index" is in the best interest of the Unit Holders.
